

# Prince William County Assistance Programs

**Northern Virginia Family Service (NVFS)** is a non-profit that offers housing services to those having trouble in areas such as housing, health, and early childhood development. To apply for help, clients need to call (571) 748-2624 and leave a message. **(571) 748-2500 | [nvfs.org](http://nvfs.org)**

Housing programs in Prince William County include:

*Affordable Rental Units* in Prince William County (primarily in the Woodbridge area) are available to those who demonstrate financial need due to their income.

*Short-term Rental Assistance Program* can offer rent/security deposit assistance. Clients must call intake line directly to learn if they are eligible.

*Utility Assistance* can be provided to clients living in Western Prince William County (including the cities of Manassas, Manassas Park, Bristow, Gainesville, Nokesville, Haymarket and Catharpin) if they have a disconnect notice and can demonstrate significant need for assistance.

**Action in Community Through Service (ACTS)** is a non-profit serving the residents of the Greater Prince William area, including the Cities of Manassas and Manassas Park with issues dealing with housing, food assistance, and domestic violence. **(703) 411-8606 | [actspwc.org](http://actspwc.org)**

*Emergency Assistance* can help prevent essential utility services from being cut off when eligible clients have received a disconnection notice from one of the following utility companies: Prince William County Service Authority (PWCSA), Virginia American Water (VAWC), Northern Virginia Electric Cooperative (NOVEC), Dominion Virginia Power (DVP), Washington Gas (WG), or Columbia Gas (CG).

**Saint Vincent de Paul Society, All Saint Conference** is a non-profit which can provide help with fuel, utility bills, mortgage/rent, prescriptions, food, and clothes. Contact directly to get more information. **(703) 368-2429**
